- 1. Bidder may download the Tender Document from the website, https://www.wbseps.com and necessary Eamest Money Deposit should be submitted through demand draft/pay order issued from any nationalized bank in favour of WEST BENGAL STATE EXPORT PROMOTION SOCIETY payable at Kolkata.
- 2. Bid should be submitted in sealed envelope along with EMD through demand draft/pay order.
- 3. Eligibility Criteria for participation in tender:
- (a) The prospective bidders shall have satisfactorily completed at least one work of similar nature.

- (b) The agencies/organizations/contractors who have executed works for WBSEPS will be given preference.
- (c) Subletting of contract is strictly prohibited.
- (d) PAN Card, Professional Tax receipts Challan for the current year to be accompanied with the Technical Bid document. Current Income Tax (Saral) Acknowledgement Receipt to be submitted.
- (e) The prospective bidders or any of their constituent partner shall neither have abandoned any work nor any of their contract have been rescinded during the last 5 (five) years. Such abandonment or rescission will be considered as disqualification towards eligibility.
- (f) Registered Partnership Deed (for Partnership Firm only) along with Power of Attorney to be submitted along with application.
- (g) Where there is discrepancy between the unit rate & the line item total resulting from multiplying the unit rate by the quantity, the unit rate quoted shall govern.
- (h) Prevailing safety norms has to be followed so that LTI (Loss of time due to injury) is zero.
- (i) Registered Unemployed Engineers' Co-operative Societies/Unemployed Labour Co-op. Societies are required to furnish valid Bye law, Current Audit Report, Current Valid Clearance Certificate from A.R.C.S. along with other relevant supporting papers.
- 4. The Bid should be submitted in sealed envelope along with demand draft / pay order of EMD.
- 5. Issuance of work order as well as payment will depend on availability of fund and no claim whatsoever will be entertained for delay of issuance of work order as well as payment, if any. Intending tenderers may consider these criteria quoting their rates.
- 6. **Constructional Labour Welfare Cess** @ 1(one) % of cost of Construction will be deducted from every Bill of the selected agency, Royalty & all other Statutory levy/Cess will have to be borne by the contractor as per rule.
- 7. <u>Adjust ment of Price (increase or decrease)</u>:- No escalation of cost will be allowed even in extension period of time, granted by West Bengal State Export Promotion Society (WBSEPS).
- 8. No Mobilisation Advance and Secured Advance will be allowed.
- 9. Price preference will be allowed as per prevailing government Order No. 1110 F, dt. 10.02.2006 of Special Secretary, Finance Department, Govt. of West Bengal. The agency claiming the preference should submit necessary documents to substantiate their claim.
- 10. Bids shall remain valid for a period not less than 180 (one hundred eighty) days after the dead line date for Sealed Bid submission. Bid valid for a shorter period shall be rejected by the "Tender Committee" as non-responsive.
- 11. All materials including cement, rods, steel sections, RBT etc. be of approved brand in accordance with relevant code of practice and manufacture accordingly and shall be procured and supplied by the agency at their own cost.

- 13. **Earnest Money**: The amount of Earnest Money is Rs. 9122/- (Rupees Nine Thousand One Hundred Twenty Two) only i.e, 2% (two percent) of the Estimated amount put to tender and to be remitted through Bank Draft / Pay Order of any nationalized Bank drawn in favour of "West Bengal State Export Promotion Society" payable at Kolkata, against the work. The amount of earnest money so deposited will be converted as "Security Deposit" for successful contractors/ firms/ companies/ organizations.
- 14. **Security Deposit**: @ 10% less the 2 % EMD converted to Security Deposit will be deducted from the bill. Security Deposit will be released after Defect Liability Period. No interest will be paid on the Security Deposit.
- 15. The Bidder, at his own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice inviting Tender, the cost of visiting the site shall be of the bidder's own expense.
- 16. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Department. The Director & Member Secretary, WBSEPS reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have incurred by any Bidder at the stage of Bidding.
- 17. **Refund of EMD**: The Earnest Money of all the unsuccessful Tenderers deposited in favour of "WEST BENGAL STATE EXPORT PROMOTION SOCIETY" will be refunded by the Director & Member Secretary, West Bengal State Export Promotion Society on receipt of application from Tenderers. No interest on EMD will be paid.
- 18. The intending tenderers are required to quote the rate offline only. No online tender will be entertained.
- 19. During scrutiny, if it is come to the notice to tender inviting authority that the credential or any other papers found incorrect/manufactured/fabricated, that tenderer will not be allowed to participate in the tender and that application will be out rightly rejected

without any prejudice. Beside the WBSEPS may take appropriate Legal Action against such defaulting tender.

- 20. Before issuance of the work order, the tender inviting authority may verify the credential & other documents of the lowest tenderer if found necessary. After verification, if it is found that such documents submitted by the lowest tenderer is either manufacture or false in that case, work order will not be issued in favour of the tenderer under any circumstances
- 21. If the dates fall on holidays or on days of bandh or natural calamity, the dates defer to next working days.
- 22. In case of inadvertent typographical mistake found in the specific price schedule of rates, where applicable, the same will be treated to be so corrected as to conform to the prevailing relevant schedule of rates and / or technically sanctioned estimate.
- 23. The intending tenderer is required to quote the amount in figures as well as in words.
- 24. No CONDITIONAL/INCOMPLETE TENDER will be accepted under any circumstances.
- 25. In case of Quoting rates, no multiple lowest rates will be entertained by the Department.
- 26. The Director & Member-Secretary, WBSEPS reserves the right to cancel the N.I.T. due to unavoidable circumstance and no claim in this respect will be entertained.
- 27. All bidders are requested to remain present either personally or through their authorized representatives at WBSEPS, during the opening of the Tender, to observe the tender opening procedure.
- 28. Successful tenderer will be required to observe the following conditions strictly:-
 - (a) Minimum wages to the workers shall be paid according to the rates notified and /or revised by the State Govt. from time to time under the Minimum Wages Act, 1948 in respect of scheduled employments, within the specified time as per law.
 - (b) Adequate safety and welfare measures must be provided as per the provisions of the Building and other Construction Workers' (Regulation of Employment and Conditions of Service Rules, 1996 read with West Bengal Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2004.
 - (c) All liabilities arising out of engagement of workers will rest on the Successful tenderer.

If there is any violation of any or all the relevant above criteria during execution of the job, it will render the concerned agencies ineligible for the work then and there or at any subsequent stage as may be found convenient.

A. TENDER COMMITTEE (TSC)

- (i) Opening of Tender:
 - Technical proposals will be opened by the authorized representative of the Additional Director, WBSEPS/ constituted Tender committee. Intending tenderers may remain present if they so desire.
- (ii) Pursuant to scrutiny & decision of the tender committee the summary list of eligible tenders will be considered.
- (iii) While evaluation the committee may summon the tenderer for clarification / information or additional documents or original hard copy of any of the documents already submitted and if these cannot be produced within the stipulated time frame, their proposals will be liable for rejection.
- (iv) The contractor is to quote the rate in the space marked for quoting rate in the BOQ mentioned under Finanacial Bid In This N.I.T.

B. AWARD OF CONTRACT.

- (I) WBSEPS reserves the right to accept or reject any Bid and to cancel the Bidding processes and reject all Bids at any time the prior to the award of Contract without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the ground for Employers' action.
- (II) The Bidder who's Bid has been accepted will be notified by the Tender Inviting & Accepting Authority through acceptance letter.
- (III) The notification of award will constitute the formation of the Contract.
- C. DEFECT LIABILITY PERIOD: 3(three) months from the date of satisfactory completion of the work. Defects detected if any, during the Defect Liability Period will have to be made good by the agency engaged for work within 7 days of intimation of the same. In case of non-compliance, the Authority reserves the right to make good such defect and the cost incurred will be adjusted from the Security Deposit.

D. PAYMENT TERMS:-

Payment will be released at a time after successful completion of the work as per measurement of the actual work executed and production of bill certified by the Officer-in-Charge.
