Government of West Bengal has planned to promote "Brand Bengal" while setting up Biswa Bangla (BB) Showrooms for showcasing host of traditional products of the State including movies, music and books, while creating a market for traditional artisans.

Biswa Bangla Showrooms are to be set up starting from Kolkata airport and will spread in major cities in India and overseas with an objective to promote Brand Bengal. In first phase, there will be 4 showrooms in Kolkata and 2 outside Bengal.

West Bengal State Export Promotion Society (WBSEPS) has been entrusted to set up Biswa Bangla Showrooms in the State and outside.

The first Biswa Bangla Showroom proposed to be set up at Kolkata airport as a green field project will offer a comprehensive platform for exhibition and sale of unique and authentic bengali products and unique merchandise to attract domestic and international businesses / visitors / buyers. There will also be provision for online order booking and delivery at customer doorstep.

WBSEPS proposes to engage a vendor (company / firm) for sourcing Bengali Movies in DVDs.

The Terms of Reference (TOR) for selection of the vendor are as follows:

#### A. Scope

- 1. Supply of Movies DVDs for Biswa Bangla Showrooms and delivery at Warehouse at Kolkata
- 2. The list of Movies currently required is given in Appendix
- 3. The vendor shall be responsible to source and aggregate all the titles where it do not have the distribution right from other such right holders and then supply the required Movies in DVD packs as is required by WBSEPS
- 4. The vendor shall ensure that the quality of the DVDs are of highest standards and shall offer replacements where quality if not upto standard
- 5. The vendor shall carry adequate inventory to enable consistent supply at all times
- 6. The vendor shall advise WBSEPS about arrival of new titles under the approved directors as stated herein
- 7. The vendor shall deliver ordered titles within 2 hours to the Warehouse in Kolkata

#### B. Time Schedule

The Movies DVDs shall be supplied within 6 days from date of issuance of Letter of Intent

# C. Terms of Payment

Payment will be made within 30 days from presentation of invoice along with delivery challan after delivery of consignment of the DVds in batches or as stated in the Purchase Order issued by WBSEPS

#### D. Bid Submission

- (a) Selection shall be made through two-bid process based on technical and financial evaluation. The bidders are required to submit a SEALED ENVELOP containing two separate sealed envelopes comprising of
  - i. Technical bid
  - ii. Financial bid
- (b) The **Technical bid** shall contain in addition to Technical bid form in Annexure-A duly filled in:
  - The company background and capability statement, supported by company registration certificate and financial statements for last 3 years
  - ii. All documentary evidence in support of the below credentials:
    - i. Experience of Music & Movie CDs & DVD retail supply
    - ii. Experience of supply of movie DVDs to retail showrooms
    - iii. Experience of music distribution for 20 yrs
    - iv. Rights of at least 40 Bengali titles of which at least 15 should be of Satyajit Ray, Ritwik Ghatak, Mrinal Sen & Rituporno Ghosh.
    - v. Direct presence in 2 or more cities with clients across India
    - vi. Ability to deliver within 2 hrs of order placement within Kolkata
    - vii. Annual turnover of minimum Rs 6 crs
    - viii. Willing to offer trade scheme

- (c) Bidders are required to fill up the **Financial Bid format** attached as **Annexure-B** with full details
  - i. The quoted amount shall include all taxes, duties, transportation & freight cost, etc. However, all applicable taxes or duties have to be mentioned separately as per statutory norms.
  - ii. The quoted amount shall be inclusive of procurement cost to source and aggregate all the titles where the vendor do not have the distribution rights from other such right holders
- (d) Bid should be submitted with Demand Draft for Application Money and Bid Security

#### E. Bid Evaluation & Selection

The broad guidelines for evaluation of bids are as follows:

- Technical bids will be opened first and evaluated on eligibility criteria and on basis of the submissions in support of the technical credentials
- ii. Financial bid of bidders whose Technical bids are found eligible and accepted will be opened.
- iii. The lowest acceptable bid will be considered further for selection of the bidder after complete clarification and price negotiations if desired / decided by WBSEPS.
- iv. If there is a discrepancy between words and figures, the amount in words will prevail.

#### F. Information Memorandum

#### 1.0 General

WBSEPS includes its successors and permitted assigns as decided by the Government of West Bengal at any time.

#### 2.0 Eligibility Criteria

- a) The **eligibility criteria** for qualification of a vendor to submit bid is given below:
  - Should have experience of Music & Movie CDs & DVD retail supply

- ii. Should have experience of supply of movie DVDs to retail showrooms
- iii. Should have experience of music distribution for 20 yrs
- iv. Should have rights of at least 40 Bengali titles of which at least 15 should be of Satyajit Ray, Ritwik Ghatak, Mrinal Sen & Rituporno Ghosh
- v. Should have direct presence in 2 or more cities with clients across India
- vi. Should be able to deliver within 2 hrs of order placement within Kolkata
- vii Should have annual turnover of minimum Rs 6 crs
- viii. Should be willing to offer trade scheme

# 3.0 Validity of Bids

The bids shall remain valid till 6 months from the date of submission and quoted price shall be valid for a period of 12 months

4.0 Cost of Bid Document / Application Money, Bid Security & Performance Security

Bid document can be downloaded from <a href="https://www.wbseps.com">www.wbseps.com</a>. The bids should be submitted with:

- (a) A Demand Draft of Rs. 5,000/- (non-refundable) in favour of West Bengal State Export Promotion Society drawn at Kolkata as **Application Money**.
- (b) A Demand Draft of Rs. 10,000/- (refundable) as **Bid Security**. The bid security of unsuccessful bidder shall be returned within 60 days of completion of bid process.

## (c) **Performance Security**:

The selected bidder shall be required to furnish a **Performance Security** by way of Bank Guarantee (from any nationalized Bank) within 3 days of issuance of Letter of Intent (LOI) for a sum equivalent to 10% of the total amount quoted and negotiated amount less the Bid Security amount and shall be valid for a period of 1 (one) year.

## 5.0 Right of Bid Rejection

- (a) WBSEPS reserves the right to accept or reject any bid and to annul the selection process and reject all bids, at any time without notice and shall not have any liability or obligation for such acceptance, rejection or annulment, and without assigning any reasons thereof.
- (b) At any time, if a material misrepresentation is made or discovered, or the bidder does not provide, within the time specified, the supplemental information sought for purposes of evaluation can lead to the rejection of the bid.

## 6.0 Bid Submission Timeline

(a) Bid submission and opening timeline are given below:

(b) If due to any exigency, the due date for opening of the bids is declared a closed holiday or any other reason, the bids will be opened on the next working day at the same time or on any other day / time, as intimated by WBSEPS. The bidders may depute their representatives, duly authorized in writing, to attend the opening of bids on the due date and time.

# 7.0 Quality

The quality of the Movies DVDs and delivery services according to the Terms of Reference shall correspond to the conditions and standards or specifications enumerated therein

#### 8.0 Inspection

Time to time inspection shall be carried out by representative / authorized agency of WBSEPS at production site, storage site, etc for Quality Assurance of the Movies DVDs and services delivered according to the Terms of Reference.

#### 9.0 Remedial Measures

Should the DVDs or delivery services thereof are not within the specified time schedule or not in accordance with the requirements of the Terms of Reference, WBSEPS shall after granting 24 hours time to cure the breach,

be at liberty to cancel the supply of the DVDs, wholly or to the extent of such default

In the event WBSEPS takes help of any third party to rectify the breach on emergency basis, the cost incurred in such an event shall be recovered from any amount payable to the selected vendor

#### 10.0 Termination

WBSPS shall be entitled to terminate agreement with the selected vendor with prior notice of thirty (30) days, in case of beach of any conditions, provisions or stipulations of the Terms of Reference for selection or non-performance that is not cured within fifteen (15) days of issue of notice.

#### 11.0 Arbitration

All disputes or differences arising out of or in connection with agreement with the selected Vendor shall be settled by bilateral discussions. Any dispute, disagreement or question arising out of or relating to agreement or relating to performance, which cannot be settled amicably, may be resolved through arbitration under the Arbitration and Conciliation Act, 1996

Agreement with selected vendor shall be governed and construed in accordance with the laws of India. Courts of Kolkata shall have exclusive jurisdiction in all the matters

## 12.0 Patents and other Industrial Property Rights

The quoted amount / rates shall be deemed to include all amounts payable for the use of patents, copyrights, registered charges, trademarks and payments for any other industrial property rights. The selected vendor shall indemnify WBSEPS against all claims from a third party at any time on account of the infringement of any or all the rights, whether such claims arise in respect of manufacture or use.

#### 13.0 Confidentiality

- (a) Selected vendor shall treat all information provided to it or obtained otherwise in connection with the services as confidential and not use the same partially or totally for any purpose without the prior written approval of WBSEPS
- (b) Deliverables of the selected vendor shall be of exclusive ownership of WBSEPS and / or its designated agencies, as applicable.

#### 14.0 Force Majeure

Neither party shall bear responsibility for the complete or partial nonperformance of any of its obligations (except for failure to pay any sum which has become due on account of receipt of goods under the provisions of the Terms of Reference), if the non-performance results from such Force Majeure circumstances as Flood, Fire, Earth Quake and other acts of God as well as War, Military operation, Blockade, Acts or Actions of State Authorities or any other circumstances beyond the parties control
